Meeting called to order by Chairwoman Gail Jones, at 8:00 am.

Carroll made a motion, seconded by Spencer to approve Maple Point A/P claims in the amount of \$37,644.16. Roll Vote: Ayes – Spencer, and Jones. Nays- None;

Old Business: Carroll who was absent at the last meeting asked about the changes to alternative

compensation. The Executive Director restated the events from the staff meetings that had taken place after the plan was announced. Several long-term employees brought concerns about what the impact would be to them and their ability to work if they change took effect. The E.D. stated again that some were legitimate

and needed consideration.

New Business: Executive Director then updated the committee on the COVID-19 status of the

building. The facility became aware of an employee who had tested positive for the virus. This employee had been fully vaccinated back in January and February

of this year. The E.D. had grave concerns that the effectiveness of the

vaccinations is starting to decrease along with the viral load increasing of the new variant strains. This initial positive case might harken in a new round of positives especially as cold, and flu traditional season increases. More worrying is that referrals are starting to come from as far as Indiana for placement at the nursing home. This is a sign that hospitals are filling up, which means infections rates are climbing and the risk to the residents of infections are increasing.

The E.D. asked if the committee had heard from Bellwether about the visibility of the nursing homes ventilation project, using the ARPA money. The committee didn't know. Ray Spencer did say that board had to the end of August to submit some kind of report. Lastly the E.D. stated that the Foundation Board had put forward Julie Glawe to replace member Dr. Ann Marty who was stepping down. The E.D. stated he had rushed to get her on the agenda for this week's county

board meeting. Ray Spencer stated it had been placed on the agenda.
