NH employees received their ARPA distribution last Friday and this would allow MP employees to receive theirs on this

paycheck.

Jones and Carroll expressed that they assumed the Executive Director thought it was okay since the committee had previously discussed extra benefits during COVID for staff though they did mention that it would be good to hear about

these things ahead of time as well.
